- 一、為提升本院學生英語能力，強化學生升學及就業競爭力，特依「銘傳大學英語能力檢定實施細則」第三條規定，訂定銘傳大學國際學院英語能力檢定實施細則（以下簡稱本細則）。

With the purpose to improve students' English proficiency, enhance their further study and employment competitiveness, Ming Chuan University International College Enforcement Rules for English Proficiency Requirements were established in accordance with Article 3 of Ming Chuan University Enforcement Rules for English Proficiency Requirements (herein referred to as the enforcement rules).

- 二、本院 99 學年度(含)以後入學之大學部學生，應通過本院「英語能力檢定」之標準後，始得畢業。本細則可追溯至本院各學程 98 學年度以後（含）入學生適用。

Undergraduate students who are admitted in the 2010-11 academic year and beyond must meet the basic English Proficiency requirement to be eligible to graduate. Students who enrolled before the 2009-10 academic year may also be required to meet the basic English Proficiency requirement to be eligible to graduate, in accordance with these enforcement rules.

四、本院大學部學生如於入學前已取得上述英語檢定考試證照者，僅認可入學年度前 3 年內取得之證書。

For any undergraduate students who have earned certificates for the above English Proficiency tests before entering this institution, only those certificates awarded within three years will be accepted.

五、本院大學部學生若持外國護照入學且英語為其母語或官方語（以本國外交部官網公告資訊為準）者，且在學期間修習英語必修課程「學術英文聽力與口說(二)」、「學術英文字彙與閱讀(二)」與「學術英文文法與寫作(二)」等 3 門必修課程學期成績皆達 80 分（含）以上者，則視為達成前條檢定標準。學生得檢附相關成績與身分證明文件，申請免修單學期零學分之「職場應用英文一」及「職場應用英文二」課程。轉學生若相關英語課程已辦理抵免者，則以原學校英語相關科目成績為辦理標準。學生若「學術英文聽力與口說(二)」、「學術英文字彙與閱讀(二)」與「學術英文文法與寫作(二)」辦理改修者，則以「高階學術英文教學訓練」、「高階英文教學實務」與「高階學術英文整合訓練」等選修課程科目成績為辦理標準。

Any undergraduate students enrolled with international passports and who are native English speakers or whose countries use English as their official language (per the notice on the webpage of Ministry of Foreign Affairs, Republic of China) and who earn 80 points or higher score for each of the three required courses, Academic English Listening and Speaking II, Academic English Vocabulary & Reading II, Academic Grammar & Writing

It will be affirmed as meeting the above requirement for English Proficiency tests. Students can apply for waiving the one semester non-credit Workplace English I and II with relevant transcript and identity document. Transfer students who apply for credit waiver will be dealt with in accordance with the scores of the English-related courses taken at their original institutions. The student's score in the elective courses, Advanced Academic English Teaching Training, Advanced Academic English Teaching Practicum, Advanced Academic English Integrated Training will be used as the standard for students who take these three elective courses instead of Academic English Listening and Speaking II, Academic English Vocabulary & Reading II, Academic Grammar & Writing II

- 六、大學部學生於四年級前仍未達前條檢定標準者，應必修單學期零學分之「職場應用英文一」及「職場應用英文二」課程，並於達成前條英檢標準或各「職場應用英文」課程及格後，始得畢業。

Should any undergraduate student be unable to meet any of the above requirements before entering their fourth year, they must enroll in the semester-long, non-credit Practical English for Professionals I and II courses, and meet the abovementioned English proficiency examination standards or pass Practical English for Professionals I and II to meet graduation eligibility.

- 七、本細則經國際學院院務會議及教務會議通過，校長核定後實施，修正時亦同。

Upon being passed at the School Affairs Committee Meeting, the Academic Affairs Committee Meeting and approved by the president, these enforcement rules were announced and implemented. Any revision must follow the same procedures.

In the event of any inconsistency or discrepancy between the Chinese and other language versions of this document, the Chinese version shall prevail.
